A Little Then and Now - For Old Time's Sake

Yes, February reminds us that it is Black History Month but mostly we want to remember this is Our History — All Day, Every Day!

Business has been on The Block for a long time. Only since the 1960's has the impact of development elsewhere in the downtown and the changes resulting from surrounding urban renewal efforts-new streets, relocations, new construction — so demonstrably

affected the former African American Central Business District.

Many still remember, though, a different time when the area was truly vital to the community in much more than symbolic ways. Albeit, there are better historians than Eagle Market Streets to provide an indepth, first-hand view of these times past. Eagle Market Streets has afterall only been on the scene since 1994, and funded only since 1997.

Yet, even in this short span of time, much has changed. Businesses have come, and some have gone, but new ones have replaced them. The high numbers of minority interests remains a constant. What has changed behind the scenes is the ownership of the property.

At first, it seemed that the once African American owned area would become gentrified. Today, for the most part, businesses rent in the area from several landlords: Building Laboratory, Southeastern Development, John Cram, MZCD, Eagle Market Streets Development Corporation and the YMICC.

Two businesses are owned privately by African Americans: The Ritz Restaurant and Lounge and the Cab Stand and Parking Lot on South Market Street. The Mount Zion



Community Development owns the largest parcel on the highest point-three foundry buildings known as the Tallman, Boozer and Spruce Street properties.

MZCD is an African American organization with a Board of Directors who are leaders in the African American community. Indeed, MZ Missionary Baptist Church is the oldest African American congregation in continuous operation since 1897.

Similar in the respect of community based benefit, the Eagle Market Streets Development Corporation owns five properties. Its Board of Directors are by law 51% or more community representatives (it is presently 90.9%). By charter and mission, the proceeds of its projects are for community benefit.

Both MZCD and EMSDC have worked to ensure that the interests of the African American community would not be lost in the development of The Block. In the effort to ensure that outcome, several studies were conducted over the years to analyze the market for the South Pack Area.

On the next page you will revisit with us the findings of the 1998 study that set the course for redevelopment projects undertaken to date.

ΓHE BLOCK Then And Now!

Take Another Look at the 1998 Area Market Analysis to See The Changes Since 1992

In early 2000, the most recent market analysis had been completed in April of 1998 through the North Carolina Institute of Minority Economic Development by Jonathan Harrison, Business Consultant.

Market conditions in the South Pack Square Redevelopment Plan Area are still varied but improving. Evaluation of market conditions included factors promoting development and impending development. Mr. Harrison noted the following:

Strengths were noted:

- Growth of the retail corridor on Biltmore Avenue and the surrounding South Pack Square area support a bright future for retail development "bleed" into the Eagle and Market Street areas
- Proximity to the governmental offices, City Hall and County Courthouse as well as Pack Square

Weaknesses included:

- Lack of cohesion of property owners/tenants in the area
- Lack of unified community and owner support
- Perceived local reputation of the area as unsafe

Target Area **Business Analysis**

The historical perspective for the business district reveals that the immediate Eagle/Market Streets Area had not gone through substantial economic development from 1993-1998 (cf., Business occupancy chart in the Market Feasibility Study for Retail and Commercial Development. Prepared for Eagle Market Streets Development Corporation, pp. 33-35 of the Harrison study.) However, substantial change had clearly occurred in the Biltmore Street area. (cf., pp. 33-35.)

Eagle Street - See Chart A

During the year since the study was completed, one shop on the south side of Eagle Street was added, Essie's 1 (Essie Covington) Treasure Chest, A Hair Boutique. On the other side of the street, Smooth's, TLC Florist, and the NC Corrections Probation Department held space on the street.

The Wilson Building at 35 Eagle in 1998 remained in disrepair; the historical barber shop sign testified to earlier use. Since 1994 Pierre's Barber Shop and Communications Office leased at the end of Eagle Street in spaces owned by John Cram, also owner of Blue Spiral Gallery fronting on Biltmore Avenue and The New Moon Gallery in Biltmore Village.

Business Clustering in Area-Usage Analysis

As seen in these foregoing chronological comparisons, the overall area has become rehabilitated to appeal to the side-



These important outreach efforts have resulted in new connections with people who otherwise could only be counted out.

walk shopper. In 1998, credit was given to Jim Samsel, John Cram, and Doug Beattie who had all done their part on Biltmore to cluster high end art galleries, wine, catering and fashions with restaurants that appeal to younger urban clientele.

The two most negative influences on the revitalized streetscape noted were the Pack Plaza Parking deck and its lease to the North Carolina Department of Corrections Probation offices, It was difficult to believe that this location is not contraindicated by the need to eliminate the blight from Eagle and Market Streets. In the years since the probation offices moved, Southeastern Development has done a great deal to enhance the community's opportunity to lease space in the storefronts on Eagle Street.

In 1998, the parking situation in Eagle Market Streets was described as problematic. Back in 2000, proposed traffic rerouting suggested in the CPTED (Community Policing Team) plan resulted in the 2005 change of traffic direction on Eagle Street between Biltmore Avenue and South Market Street being reversed. Real and workable solutions that serve the entire area well have yet to be determined. However, the continued use of area surface parking at Mount Zion Missionary Baptist Church, at the Jones Cab Stand, at 40 South Market and on street have helped the downtown in its ongoing demand for increased parking.

Developers often express that the access for pedestrians and cars off Biltmore Avenue would be enhanced by making the businesses along the south side of Eagle Street more attractive. There has been interest in developing Wilson Alley into an Arts Alley. The vast improvement in the facade of the Wilson Building, the first building viewed when turning the corner from Biltmore onto Eagle Street, has been very helpful as has the rerouting of traffic from Biltmore Avenue onto Eagle Street.

Dressing up the buildings that property owners have been asked to wait to refurbish is another step in meeting the needs of the existing merchants and landlords. In 2000, one writer proclaimed that "Even if the aesthetics did not take your breath away, the stench from the portal of the Wilson Building would."Thanks to **Building Laboratory** LLC, the restauranteurs and other tenants, this has changed and had a very positive outcome for the street.

As suggested in the Harrison study, there is a strong sense among developers that the area needed a "contextual" change with a streetscape linking the Block to Biltmore Avenue. During the planning for Pack Square Renaissance (City/County plaza renovations now underway), those linkages have been suggested to include vistas onto The Block from The Plaza and compatible street lighting and amenities.

In 2000, Artsy World (closed in 2005) on the corner of the Biltmore Avenue and Eagle Street, was the first indication that there was an ethnically rich experience somewhere nearby. The CDC called for a gateway design to create that passageway into the showcase of culture, history and spirituality ahead on The Block.

The Eagle sculpture remains all but invisible in its present setting (then and now). Once the Eagle catches the shoppers' attention, better signage can entice them into the area. In 2000, the CDC gave kudos to Essie Covington for her new signage in black and gold. Hanging baskets of flowers and earth-toned banners could be used to encourage the journey. While Southeastern Development has done much to improve the appearance of the parking garage, much remains to enhance this entryway.

The YMI when interviewed in 1997 projected its future as an anchor in the target area and one with the political capacity to be a "spark plug" for development if it is properly engaged. The organization was then concentrating on social service mission of providing space for non-profit organizations for education and the cultural arts. It complements the development process by helping to return foot traffic to the area and by being a catalyst for the area.

The French Broad Food Coop in 1997 had 2000 members representing 1500 households. Early efforts to involve the Coop as a partner in the development effort have been untested in recent years.



One suggestion in NCIMED study was to a build staircase from South Market Street to connect the two communities. This coupled with the suggestions in the CPTED plan with respect to improved lighting in the area of Triangle Park are important in making the area more pedestrian-friendly.

That was the essence of the 1998 study. In 2007, much remains to be completed from those suggestions and recommendations. Two more important feasibility and marketing studies have been completed by area stakeholders since that
