

WHEREAS, Dr. Grant has faithfully served as the visionary leader, Pastor and President of Mt. Zion Missionary Baptist Church of Asheville, Inc., for 36 years; and

WHEREAS, under Dr. Grant's visionary leadership, services rendered by Mt. Zion Church are not merely ideals, but a foundation for many and a social justice platform that often fills the gaps in access to services and resources to meet the needs of the whole person locally, statewide, nationally and internationally; and

WHEREAS, Dr. Grant's ministry is committed to preaching, teaching, and witnessing the gospel of our Lord and Savior Jesus Christ; this commitment led to the establishment of Mount Zion Community Development, Inc. (MZCD), founded by Mt. Zion Church under his leadership, and where he served as Founding Chairman, President and CEO; and

WHEREAS, MZCD has raised and invested millions of dollars in program initiatives, too many to mention; and

WHEREAS, Dr. Grant helped organize the Eagle-Market Streets Development Corporation, serving as the Founding President, Chairman & CEO for three years and helping the corporation secure its 501(c)(3) IRS exemption status, more than a quarter of a million dollars in grant funds, gain official recognition as a development partner with the City of Asheville and hire its first full-time executive director; and

WHEREAS, in 1998, Dr. Grant helped organize Community Outreach, Incorporated, a 501 (c) 3 non-profit that rescued the YMI Cultural Center ("YMICC") from foreclosure at a cost of more than \$30,000,00; and

WHEREAS, Dr. Grant is known as a man of integrity and accountability and the recipient of many honors including Buncombe County's "100 Most Influential People," "Minority Enterprise Week Minister of the Year," "Certificates of Special Congressional Recognition" for three years, Martin Luther King, Jr. "Church of the Year" award for "reflecting the spiritual values of Dr. King's stand for social and economic justice, the empowerment of others, and the sacrifice of time and resources to benefit the impoverished and disenfranchised of our community;" and several proclamations declaring "Dr. John H. Grant Day."; and







October is SIDS and Pregnancy and Infant Loss Awareness Month, a time to educate the public on Sudden Infant Death Syndrome (SIDS), promote safe sleep practices to reduce sleep-related infant deaths, and honor the memories of infants lost during pregnancy and early life.

Key initiatives include the ABCs of Safe Sleep (Alone, Back, Crib), which advises placing babies on their backs to sleep in a crib without blankets or toys. Additionally, the month recognizes families who have experienced perinatal loss, offering support and a platform to share their stories and grief.
